**GENERAL MEMORANDUM OF UNDERSTANDING FOR COLLABORATION
BETWEEN**

ANKARA UNIVERSITY (Republic of Turkey)

With its registered address at De Gaulle Cad. Beşevler 10.Yıl Yerleşkesi Emniyet Mah. Yenimahalle 06560 Ankara, Turkey represented by Mr Erkan İbiş in his capacity as Rector in accordance with his appointment by Decree 2012/23 of July 6th 2012 of the Turkish Government, and his second appointment by Decree 2016/60 of July 28th 2016, in line with article 130 of the Constitution of the Turkish Republic and clause 13 of the article 2547 of the Law of Higher Education.

AND

THE UNIVERSITAT JAUME I (Spain)

With its registered office in the city of Castelló de la Plana, represented by Eva Alcón Soler in her capacity as Rector in accordance with her appointment by Decree 70/2018, of 1 June, of the Valencian Government, and in accordance with the powers given to her by Article 70.1.t of the Statutes of the Universitat Jaume I, approved by Decree 116/2010, of 27 August, Council of the Government of the Valencian Community.

RECITALS

1. The two entities have shared academic, scientific, cultural and social objectives and interests.
2. The Universitat Jaume I is a higher education and research institution committed to the social, economic and cultural development of its surrounding society through the creation and transfer of knowledge.

To meet its objectives, the Universitat Jaume I is oriented towards its environment and is increasingly aware of the need for collaboration between all institutions committed to social development.

3. As the two entities find themselves in a shared social, cultural and economic sphere, collaboration programmes between them will improve the services they provide to society.

4. Given the above, both institutions see fit to outline in a general memorandum of understanding certain aspects, such as their academic, scientific and other ties, and establish a framework for collaboration.

Therefore, the parties wish to sign this general memorandum of understanding for academic, scientific and cultural collaboration in accordance with the following:

CLAUSES



1. Purpose of the collaboration agreement

The Universitat Jaume I and Ankara University shall establish, via agreements incorporated into this general memorandum of understanding, the specific forms of collaboration in the areas in which both entities have a manifest interest.

They shall also foster the development of projects of common interest under the collaboration framework.

2. Forms of collaboration

To satisfy the objective defined in the previous clause, both parties shall, in accordance with the means at their disposal and the current legislation:

- 
- a) To supply joint studies and research projects on common interest.
 - b) To favour professors' and researchers' stays for concrete periods to take part of academic activities.
 - c) To provide each other with mutual guidance and to carry out joint collaboration projects and programmes concerning matters related to the activities the two institutions are involved in.
 - d) To facilitate the exchange of students, professors and administrative staff between both institutions.
 - e) To carry out any actions deemed to be of mutual interest lying within the scope of the activities the parties are willing to perform and the issues that constitute the purpose of this agreement.
 - f) Advise each other and jointly develop collaboration projects and programmes on matters related to the activities of both entities.

3. Implementation of the collaboration

The forms of collaboration set out in this agreement are performed via a programme created by both entities, which is implemented via additional agreements to this instrument. The agreements must be subject to the approval procedures established in the statutes, regulations, etc., of each entity.

4. Funding

This agreement does not give rise to any financial obligations for the parties. For each initiative, each agreement must state the activities to be performed, the persons and institutions involved, the resources available, the budget, the term, and the funding.

5. Term

The term of this agreement is four years, which may be extended implicitly. Either party may terminate the agreement by providing due, written notice three months prior to the termination date. Any such early termination does not affect the specific agreements entered into, which must be performed and terminated in all cases as specified therein.


6. Disputes

Without prejudice to the competences of each entity, any disputes arising out of the performance of this memorandum of understanding or the agreements implementing it must be examined and resolved by a joint committee made up of four persons, two representing the Universitat Jaume I and two representing Ankara University.

The parties shall submit any dispute that cannot be resolved by this committee to the administrative courts.

The parties are signing two counterparts of this document at the place and on the date set forth above.
