

**MEMORANDUM OF UNDERSTANDING
BETWEEN**

INTERNATIONAL ISLAMIC ACADEMY OF UZBEKISTAN

AND

ANKARA UNIVERSITY

This Memorandum of Understanding is made on the day of2019.

ANKARA UNIVERSITY (AU) and **INTERNATIONAL ISLAMIC ACADEMY OF UZBEKISTAN (IIAU)** shall hereinafter be referred to singularly as “the Party” and collectively as “the Parties”.

THE PARTIES HAVE REACHED THE UNDERSTANDING as follows:

ARTICLE I

1. The cooperation involves collaboration between International Islamic Academy of Uzbekistan and Ankara University in:

1.1 Exchange of Staff

1.1.1 Joint curricular activities in education and teaching, such as summer schools and diploma programs

1.1.2 Exchange of research and teaching staff

1.2 Exchange of Students

1.2.1 Exchange of undergraduate and graduate students

1.3 Exchange of Material

1.3.1 Joint extra-curricular activities in academic and scientific fields, such as certificate courses, conferences and symposia.

1.3.2 Collaborative research projects and studies

1.3.3 Collaborative academic and scientific publications

1.3.4 Exchange of academic publications and scholarly documents

1.4 Post-Graduate Degree Programs

1.4.1 Collaboration on Doctoral student exchange and on writing co-supervised Doctoral thesis

ARTICLE II

2. Terms of Cooperation

Cooperation terms for each activity implemented under this MOU shall be agreed upon by both parties in writing, prior to the initiation of that activity. Any such agreement will form an Appendix to this MOU.

2.1 All activities shall be in accordance with the regulations and policies of AU and IIAU.

ARTICLE III

3. Financial Arrangement

3.1 This MOU will not result in any financial obligations. Each institution will be responsible for its involvement in cooperative activities and all such activities will be dependent upon the budgetary appropriations of the parties.

ARTICLE IV

4. Renewal, Termination and Amendment


4.1 Upon approval by each institution, this MOU shall remain in effect for a period of five (5) years. At the end of five years, this MOU will automatically be extended for another five-year period unless otherwise determined.

4.2 This MOU may be revised through the mutual agreement of both universities and may be terminated by either party upon giving twelve months written notice signed by the presiding office of the notifying party. All modifications to this agreement will be in writing, signed by both parties.

The foregoing record represents the understandings reached between the **INTERNATIONAL ISLAMIC ACADEMY OF UZBEKISTAN** and **ANKARA UNIVERSITY** upon the matters referred to therein.
