



MEMORANDUM OF UNDERSTANDING (MoU)

BETWEEN



GOVERNMENT COLLEGE UNIVERSITY, FAISALABAD (GCUF)

&

ANKARA UNIVERSITY, TURKEY

This Memorandum of Understanding is made and executed at ANKARA, on this 3rd day of April, 2019, between The Government College University, Faisalabad, through its Vice Chancellor (herein after called 1st Party) and Ankara University, Ankara, through its Rector (herein after called 2nd Party).

PREAMBLE AND MAIN OBJECTIVES

Both Parties are well reputed higher educational institutions of their countries. They annually produce undergraduate and post-graduate students in a large number of disciplines ranging from science and technology, engineering and management sciences. Both institutions are also involved in research work and have the capability to provide solutions to the research problems.

WHEREAS, both the parties are desiring to work in collaboration based on the principles of mutual benefit and respect for each other's independence, the two Universities will work together to cultivate student and academic staff exchanges, joint research and other mutually desired and approved academic activities.

BOTH THE PARTIES ARE AGREED UPON THE FOLLOWING TERMS AND CONDITIONS


Government College University Faisalabad, Pakistan and Ankara University, Turkey with the purpose of developing academic exchange and cooperation in education and research between the two Institutions, have agreed to the following:

1. Exchange of scientific and instructional information, research and extension publications, samples and educational materials
2. Exchange of faculty for research, teaching and other collaborative activities
3. Exchange of faculty to participate in conferences, symposium, workshops and seminars
4. Exchange of undergraduate and / or graduate students for specific periods of study through an organized study abroad agreement
5. Establishment of joint research projects on subjects of mutual interest

6. Both the parties will coordinate the activities and exchange of research, teaching and extension information and publications will be developed when appropriate to the interests of both universities
7. In order to carry out the aforementioned activities, a detailed plan will be developed and agreed upon after consultation between both the parties
8. Each and every activity undertaken through this agreement will be approved by the appropriate officials at each Institution and must fall within each Institution's academic and fiscal constraints
9. This agreement shall be effective on and after the date of its signing and shall remain in force until either party wishes to terminate it, with six (6) months' prior notice
10. This agreement may be modified at any time after consultation between both the parties.

IN WITNESS WHEREOF, parties have hereunder set their respective hands, on this day of 3rd of April 2019. This agreement will be signed on behalf of Government College University Faisalabad by Prof. Dr. Farhat Jabeen, Dean Faculty of Life Sciences in the witness of Prof. Dr. Hasan H. 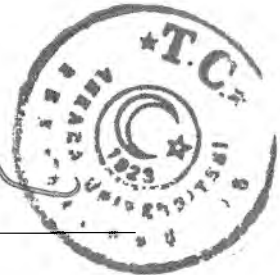


