

COOPERATION AGREEMENT
between
Ankara University (Ankara, Turkey)
and

Saratov State University (Saratov, Russian Federation)

Ankara University in the person of the rector, Professor Dr. Erkan İbiş, on the one hand, and Saratov State University in the person of the rector Chumachenko Alexey Nikolaevich acting under the Charter, on the other hand, collectively referred to as the «Parties», and separately as the «Party», for the purpose of establishment of mutually beneficial partnership, development of the educational and research sphere signed this agreement (further – the Agreement) on cooperation:

Article 1

The purpose of this Agreement is to strengthen and develop cooperation in the field of education, research and culture.

Article 2

The Parties will cooperate in the sphere of education in the following fields:

- 2.1. Exchange of students under the academic mobility program;
- 2.2. Exchange of teaching and academic staff, doctoral, master and undergraduate students; organization of academic trainings;
- 2.3. Invitation of the Parties' representatives for giving lectures, sharing experience and information on educational and methodological work, as well as curriculum and study programs;
- 2.4. Implementation of joint research projects, holding conferences, seminars, round tables and other events in the sphere of education; international cultural relations development;
- 2.5. Support for implementation of all other cooperation forms in the field of education;
- 2.6. Publication of research studies in the printed editions of the Parties; exchange of publications, teaching materials, periodicals, information on the activities carried out according to the results of joint work.

Article 3

- 3.1. The Parties have to enter into separate agreements establishing legal and financial obligations of the Parties to implement joint programs and projects.
- 3.2. The Parties may involve potential financial partners and funds for programs and projects implementation.

Article 4

The Parties take into account that all visits of the Parties' employees, as well as teaching staff and students; entry and stay on the state territory of each Party will be regulated by the laws in force of the Republic of Turkey and the Russian Federation, as well as relevant local regulations in force of the universities.

Article 5

- 5.1. Specific activities and conditions of cooperation under this Agreement will be additionally determined by the Parties by conclusion of individual contracts.
- 5.2. The Agreement can be amended and supplemented by mutual consent of the Parties by signing additional agreements, which will be its integral part and must be duly executed and signed by authorized persons of the Parties.

Article 6

- 6.1. This Agreement is effective as of the date of its signing and shall remain in force for five years with the right of prolongation for further five years from the expiration date of the relevant period, unless either Party notifies in writing the other Party of its intention to terminate the Agreement.

6.2. This Agreement may be terminated at any time by either Party. Each Party should notify in writing the other one about the Agreement termination at least six months before the expiration. In this case, the application period of the Agreement will cease to six months after the receipt by one of the Parties of such notification sent by the other Party.

6.3. Joint activities of the Parties, not completed by the time of this Agreement termination, may be continued until its completion by agreement of the Parties in accordance with the provisions of this Agreement.

6.4. The Parties will promptly notify each other about controversial issues and difficulties related to implementation of programs and projects. All issues and disputes related to implementation of this Agreement will be resolved by mutual agreement of the Parties.

Article 7

This Agreement is made in English in two counterparts, one for each party. Both texts have the same legal force.


