

PROTOCOL ON COOPERATION
BETWEEN
ANKARA UNIVERSITY
AND
TASHKENT TEXTILE AND LIGHT INDUSTRY
YULDASH AHUNBAEV INSTITUTE

Ankara University and Tashkent Institute of Textile and Light Industry have agreed to cooperate in order to improve, promote and strengthen the mutual relations between Turkey and Uzbekistan through their collaboration in academic, scientific and cultural fields. In order to accomplish these aims the two parties have agreed in the followings.

I

1-The two institutions will cooperate in finding solutions for scientific problems of mutual interest and will exchange experiences about the forms of education and problems of organization.

2- Cooperation will be emphatic in the following fields :

-Exchange of student and academic staff.

Both parties agree to exchange a group of ten persons consisting of two lecturers and 8 students for the beginning on currency-free exchange basis taking the principle of mutuality and the exchange of the same values into consideration.

In case one of parties fails sending a group of exchangees it still is required to receive a group as indicated in this protocol. The sending party agrees to inform receiving party at least 30 days before the date of departure.

-Mutual further training of young undergraduates and graduate experts.

-Exchange of publications.

-Providing mutual information on and inviting to scientific meetings.

-Exchange of student for professional practise-purposes.

II

Both parties have agreed to cooperate in the following fields for the beginning and if necessary will broaden their field of mutual interest.

-Light Industry and Textile

-Home Economics

-Agricultural Economics

-Free Market Economy

-Business Administration

III

For the implementation of this protocol the parties will prepare a working programme detailing the specific forms and contents of cooperation. Once such a programme is approved by the parties it will become a part of the protocol and new suggestions will be made not less 5 months before the beginning of the programme.

Yearly quotas, duration of visits and other related matters will be indicated on the yearly programmes.

IV

Both parties also agree to promote cultural relations between their members and students. For this purpose both parties agree to exchange opinions.

V

Both parties agree to support this protocol in order to provide maximum efficiency for their exchange staff and students. The obligations of the two parties are to be detailed in the working programmes.

VI

The travel expenses will be paid by the sending party and boarding-accommodation expenses in addition to a small amount of pocketed money will be paid by the receiving party.

In case of sickness and accidents the receiving party will provide medical assistance.

VII

This protocol will come into force after being signed by the Rectors of both parties and will remain valid for 5 years. Its validity will be prolonged for another 5 years unless its termination is announced by one of the parties six months prior to the date of expiry.

VIII

This protocol has been prepared in English and Turkish two copies of each version. Both versions are equally valid.
