

AGREEMENT ON COOPERATION  
IN THE SPHERE OF SCIENCE TRAINING OF SPECIALISTS,  
TEACHING OF STUDENTS, SPORT AND TOURISM BETWEEN  
TASHKENT MEDICAL INSTITUTE OF HEALTH MINISTRY  
OF THE REPUBLIC OF UZBEKISTAN AND ANKARA UNIVERSITY  
OF THE REPUBLIC OF TURKEY

Ruled by aspire to strengthen friendship and mutual understanding between the two countries and peoples, in the interest of mutually beneficial cooperation in the sphere of science, training of speacialists, teaching of students, sport and tourism, Tashkent Medical Institute of Health Ministry of the Republic of Uzbekistan and Ankara University of the Republic of Turkey, named hence forward as "Parties" agreed upon the following:

Clause 1

Parties will carry out joint scientific researches, training of specialists in medicine, teaching of students and holding conferences, scientific meetings, and implement exchange by sport and tourist delegations on mutually beneficial, without use of foreign currency, basis

As the first step Turkish party has agreed to accept for teaching of 10 (ten) students in medicine and language training 1992.

For the next years the numbers of students will be determined by parties additionally

#### Clause 2

Parties will implement exchange by chess, basketball (men, women), volley-ball, tennis, track and field athletics, sport delegations.

#### Clause 3

Each delegation can consist of up to fifteen members, duration of stay of the delegation in receiving country is seven days. It is planned to conduct one meeting in each event in each country.

#### Clause 4

Receiving party takes upon itself commitment to provide transport from the State border on the territory of the country for the whole duration of stay of the delegation in the receiving country.

#### Clause 5

Time of arrival, i.e. crossing of the State border stipulated during discussions of the yearly programme and additionally informed to the receiving party not later than 30 days before estimated time of arrival. Sending party in its turn sends confirmation not later than 10 days before estimated time of arrival.

#### Clause 6

Receiving party provides accomodation for the members of the visiting delegation in double rooms with bathroom with cold and hot water and public conveniences, breakfast, lunch and dinner, cultural programme, poket money equivalent to 5.- per day in the currency of receiving country.

#### Clause 7

Present agreement does not exclude the possibility to conduct other arrangements of cooperation, which can be coordinated by the parties additionally.

#### Clause 8

Exact dates of the sport events and other current points will be stipulated in the yearly working programmes of cooperation. For working out and signing of the programmes parties will be exchanging delegations of planipotentiary representatives.

#### Clause 9

Present agreement comes into force from the moment of approval by the Parties competent authorities and is in force for five years, In case six month before the termination of the term of agreement Parties will not inform in writing about the intention to terminate the agreement, its term will be prolonged automatically for the next five years.

Clause 10

Present agreement is signed in five copies in Turkish,  
Uzbek and English all texts are equally valid.



